

**DESCRIPTION:**

**DIRECTIONS:**

Ferric Bind's dosage can vary depending on conditions, but typically ranges between 50 to 200 ppm

**INGREDIENTS:**

Ferric Chloride Solution.

**DANGER!** Corrosive Material!
