4.1. Description of first aid measures

5.1. Extinguishing media

5.2. Special hazards arising from the substance or mixture

Fire hazard : Flash Point 107 F (Closed Cup). However this product did not sustain combustibility per ASTM 4206, Standard Test Method for Sustained Burning of Liquid Mixtures Using the Small Scale Open-Cup Apparatus.

Explosion hazard : Product is not explosive.

Reactivity : No dangerous reactions known under normal conditions of use.

5.3. Advice for firefighters
